  10. The School shall submit building fitness certificate, NOC from chief Fire officer, water safety certificate from DJB and health certificate from local competent authority within six months of its date of application.
  11. The School shall comply with the directions of the Hon'ble Supreme Court of India regarding the arrangement made for transporting school students.
  12. Salary to the staff shall be paid through crossed Cheque/Electronic clearance system.
